## **Recycle Center Updates**

We continue to encourage all residents to recycle, as through our program with Brown County we may get rebates on recyclables.

Reminder that our hours of operation are from 9 am-1 pm on Saturdays and 4-8 pm on Wednesdays. During the winter, when inclement weather occurs, we will continue to be open unless the temps are extreme and/or winds are high.



## BROWN COUNTY DRAINAGE DISTRICT #4

The Brown County Drainage District No. 4 encompasses a portion of the northwestern part of the Town. The district maintains ditches located in the area that were constructed years ago to drain some of the wet areas within the district. Drain tiles have also been installed in some of the farmland of the area to help drain water into the ditches. The district is a taxing authority, and its costs to maintain the district are received from property owners located within it. It is illegal to tap into the drain tile or alter the drainage ditches located in this district. If in doubt please contact the Town board or the Drainage district board for correct and current info. Also, you can see the mapped area in our comprehensive plan located on the Town website.

#### **BUILDING PERMITS**

Any and ALL building of structures needs land use/zoning permit followed by a building permit. To begin the process, please contact the zoning administrator – Norb Dantinne at 920-371-7040. The Town's building inspector is Brett Guillette at 920-495-3232 and MUST be notified prior to construction. Any questions, please contact a board member. Also, if a shed is permitted as "personal use only", you CANNOT operate a business from that site. IF you do, you may be cited and fined for operating without a conditinoal use permit.

We once again remind everyone – NO pushing snow across the road and leaving a berm or pile on the road edge. This is a hazard to the snow plow drivers and other safety vehicles as well as regular vehicles. If we need to address this issue, you may be receiving a citation if a repeat offender!

## 2024 Election year

## **DOG LICENSE**

The annual dog tags are in for 2024 and can be purchased at any time.

### ALL DOGS MUST BE LICENSED BY APRIL 1: LICENSE RATES ARE FOR EACH DOG:

Male & Female \$8.50

Neutered Male & Spayed Female \$3.50

ANYONE THAT HAS 4 OR MORE DOGS ARE REQUIRED TO PURCHASE A KENNEL LICENSE OR MULTIPLE DOG LICENSES:

Multiple Dog License (Up to 12) \$36.50

\$5.00 late fee for dogs licensed after April 1

Owners must present their RABIES VACCINATION CERTIFICATE that their dog is vaccinated against rabies by a veterinarian before the dog can be licensed. I also need the Pet Owners phone number for Dog license report sent to the Brown County Clerk's Office. THIS RULE WILL BE STRICTLY FOLLOWED!!

**Property taxes** will be mailed in early December from the Brown County Treasurer's office. Make all checks out to that office. You can pay either by mail or in person at the County Treasurer's office. Also check your tax bill if you have a lottery credit. If it is your primary residence, you are entitled to receive a lottery credit.
